Declaration in accordance with Article 33 of the REACH Regulations (EC) No. 1907/2006 and Substance of Very High Concern (SVHC)- Lead content

Under the European Union Registration, Evaluation, Authorization of Chemicals Regulation 1907/2006/EC (REACH), businesses have obligations should an SVHC be present above a threshold of 0.1% weight by weight. Obligations include providing sufficient information to allow safe use of the article including, as a minimum, the name of that substance.

The latest 241 substances restricted per the REACH Regulation were last updated on 27th June 2024 and the complete and latest list of SVHCs can be found on the ECHA website:



Lead is commonly used in steel and brass alloys to improve machining properties. A variety of Guy-Raymond products use components manufactured from these alloys containing lead at or above the 0.1% threshold. Some Guy-Raymond products contain steel which contains lead at 0.3%, details on these parts can be found below.

The main routes to lead exposure are ingestion and inhalation. Permeation via skin is minimal, in particular when the substance is contained in a metal matrix. There are no special requirements for safe use of the products.
